1. NAME OF THE TRUST: SRI OONJALI CHARITABLE TRUST.
2. OFFICE OF THE TRUST:

The office of Principle place of the trust shall be at S.No. 1133/4 Kadamalaigundu-Myladumparai Main Road, Opp: Forest Office, Kadamalaigundu (po), Aundipatti (TK), Tamilnadu. It shall be open to the Trust to open such other office or offices, or place or places of activities, centers, or areas of operation in such other place or places, as the Trustees may deem fit and proper. The performance of the objects of the Trust shall, however, be confined to the Territory of India.

3. OBJECT OF THE TRUST:

The object for which the Trust is established shall be charitable in nature ensuring for the benefit of the public without discrimination or distinction of caste, Creed or religion. Each of the objects shall be independent of the other and the objects shall comprise the following:

(a). EDUCATION:

To promote Education in General and Particularly Primary and secondary School, college of Engineering including Computer Engineering and College of Arts, Science, Nursing, pharmacy and Medical giantess and for this purpose.

(i). To set up, maintain and promote educational institutions, academics, foundations, classes, lectures, conference, gatherings and other mediums.

(ii). To give provide support finance and extend scholarships, Contributions, fellowships and render other assistance to deserving candidates, Students, teachers, Scholars and economically poor.

(iii). To do everything which is necessary in this regard as the trustees may deem fit and proper from time to time.

(iv). To provide Skill development for all type of students, Social welfare People and other persons.

(b) MEDICAL RELIEF:

(i) To set up, run, Promote and maintain hospitals, clinics, rehabilitation centers, institutions, homes or organizations, providing medical relief and rehabilitation for the sick and the infirm;

(ii). To grant assistance or aid and to donate or finance the acquisition of medical equipment's, hospital requisites, medicines and other articles, things and equipment's, required or needed by the sick, the infirm and the Needy one.

(iii) To do such other and all deeds and things as are necessary or conducive to providing medical relief.

(c) OBJECT OF PUBLIC RELIEF:

(i). To construct, run, maintain, support, finance or otherwise assist institutions, or centers, for imparting training, apprenticeship, experience in handicrafts, home science, household management, cookery, needle work, tailoring, cottage industries and other arts, crafts, vocations, or other avenues for employment for deserving boys and girls.

(ii). To impart training and providing facilities for such training to develop the moral and cultural knowledge; health and status of boys and girls so as to develop them into responsible and respectable citizens.

(iii). Each of the aforesaid shall be independent of the other and shall be performed and carried on as an independent object not dependent on or related to the other.

(iv). Each of the objects aforesaid shall be pursued as a wholly charitable object without profit motive. None of the aforesaid objects shall involve the carrying on of any business or trade or other activity for profit.

4. TRUST FUNDS:

(i). The Trust funds shall consist of the amount transferred by the Founder of the Trust, as herein before contained and all other or further amount or amounts, assets, properties whatsoever as the Trustees may deem . fit and proper to accept in their discretion in regard to this matter which is final and conclusive and all contributions, donations, or gifts received by the Trust, the income, profits, or gains arising there from and all accumulations, and accruals of such profits or gains or surpluses out of the funds or amounts received by the trustees, after meeting the expenses and the funds applied for the objects of the Trust.

(ii). The Trustees shall have the power to accept any amount, assets or properties transferred to the Trust by any person or persons as and by way of gifts or otherwise. The amounts, assets or properties so received shall form part of the Trust Fund together with the existing fund and the income arising there from.

(iii). The Trustees shall hold the Trust funds for the sole benefit, use and application towards objects of the Trust and no Part of the Trust Fund Shall be disposed of or distributed to the Founder or the Trustees, or to persons having substantial interest in the Trust except in the manner here in contained.

(iv). It shall be open to the-Trustees to receive any subscription, donation or contribution, towards the corpus Of the Trust fund or otherwise and impose. Such conditions, restrictions or terms with regard to the acceptance of the gifts, donations, or contributions. The decision of the Trustees in this regard shall be final and binding on the Trustees and shall not be called in question by any person.

5. BENEFICIARIES UNDER THE TRUST:

The Trust shall be a public charitable Trust open to all persons irrespective of caste creed, religion, or community with in the territory of India. The Trustees, however, shall have the discretion to determine the persons who shall be afforded the benefits under the Trust and the decision of the Trustees in this regard shall be final and shall not be called in question by any person. The Founder will be the president who has every power to veto whichever is prejudicial and detrimental to the Trust and its objectiveness or whichever he deems objectives or whichever he deems objectionable cause.

6. BOARD OF TRUSTEES:

The affairs of the Trust shall be managed by a Board of Trustees consisting of not fewer than three and not more than Nine Trustees. The Trustee K.Ponnammal , W/O. S.Kandasamy had been resigned from our Trust and New Trustees are Admitted into Trust from Now

On Account of misconduct or gross negligence on the part of any Trustee, it shall be Open for the other trustees to pass a resolution by a majority that such a trustee is discharged and from the date of such a resolution such a Trustee shall be considered to have been discharged.

No person being an undischarged insolvent, person convicted of an offence involving moral turpitude, unsound mind or a minor shall be eligible to be a Trustee.

A person shall cease to be a trustee if he dies, becomes bankrupt, insolvent, insane or otherwise incapable to act and resign from Office.

In the event of any vacancy arising in the office of the above- mentioned Trustees, the managing Trustee shall nominate a person to the vacancy and his term of office will be decided by the managing Trustee.

After the lifetime of the managing Trustee, the Trustees by majority decision shall fill up any vacancy in the office of the Trustees and period of office of such Trustee shall be determined by them. Such Trustee is eligible for reappointment.

7. MANAGING TRUSTEES: -

Founder Sri. S.K.Kumaresan shall be the Managing Trustee, during his lifetime. The founder shall nominate a successor to carry out the duties of the Managing Trustee.

In case, to manage the trust, The Managing Trustee could not nominate a successor during his lifetime, the other Trustees, by a majority decision shall choose a suitable person with the desired level of knowledge to be the managing Trustee and the office of such successor shall be determined by the Trustees. If the successor or Managing Trustee does not perform up to the expectations of trustees he/ she can be removed from office by a majority decision of the Board of Trustees.

The Managing Trustee shall be vested with the power to manage the day-to-day affairs of the Trust.

8. POWERS OF THE TRUSTEES:

(a). The Trustees shall exercise the following powers at their Board meetings, provided, however, that the power incidental to the day-to-day management of the Trust shall be exercised by the Managing Trustees, acting by himself or through any one of the Trustees

(i). To employ-clerks, and other employees, agents, bankers, brokers, lawyers, accountants and others at such remuneration as they think fit.

(ii). To delegate any power as they can lawfully delegate to any person and to execute such power of attorney as they may think fit for the purpose.

(iii). To withdraw any power, to revoke any appointment of any employee or attorney.

(iv). To invest the trust funds as per the approved pattern of Investments prescribed under the Income Tax Act 1961 as now and as may be amended from time to time.

(v). To convert call in, sell, or otherwise, dispose of any of the movable investments comprised in the Trust properties and re-investments or change the nature of any other investment contained there in.

(vi). To let any -portion of any immovable property forming of the Trust Property/Fund at such rent and for such period and on such terms and conditions as they may think fit and to accept surrender of any lease.

(vii). To open maintain or operate bank accounts in-the name of the Trust or such one or more of the Trustees, as they may think fit and to make the account or accounts operable by such one or more of them as they may think fit.

(viii). To institute, conduct, defend, compound or abandon any legal proceedings by or against the Trust or Trustees and allow time and indulgence for payment or satisfaction of any debt dues or any claim or demand by or against the Trust.

(ix). To obtain payment of money, from all courts, banks Government officials, Treasury officials assigners, official receivers, post offices and all other offices of the central, states or local authorities.

(X). To appear before the Registrar of Assurances, sub-registrars of Assurances or any other official appointed for registration of deeds, assurances, documents and other instruments in order to execute or consent and admit execution and register or cause to be registered deeds of assurances, documents etc., in which the Trust is intersted or involved:

(xi). To borrow monies for the purpose of the Trust on such terms and conditions as may be agreed to by the Trustees and to authorise any one or more of them to execute such documents including the deeds of mortgage, charge or hypothecation, as may be necessary for the said purpose and also to create any mortgage or charge on any of the Trust Properties movable or immovable for the said purpose.

(b). The Board of Trustees shall exercise the following powers by a decision of two-third majority of the Trustees present and voting at the meeting of Board of Trustees. In computing two-third majority any fraction, even if it is greater than 0.5, shall be ignored.

(i). To buy or take lease immovable properties for the Trust and / or to put up buildings or structures on the land belonging to or under the control and possession of the Trust.

(ii). To sell, gift, transfer or alienate in any manner any property or assets of the Trust movable or immovable.

(iii). To alter the Trust deed

9. ACCOUNTS:

(a) The trust shall maintain regular accounts of all its transactions showing clearly the receipts and expenditure.

(b) The accounts of the Trust shall be audited by a Chartered Accountant and approved by the Board of Trustees with in period of Six months from the end of the relevant accounting year.

(c) Accounting year of the Trust shall be from 1 St of April to 31 st Day of March every year.

10. MEETINGS:

The meeting of the Board of trustees shall be held at least once in six months and the Trustees shall comply with all the relevant statutory obligations.

11. INVESTMENTS:

(a). The trust shall invest its trust funds in securities as are permitted under provisions of section 11 and 13 of the Income Tax Act 196] as amended from time to time. No investment shall be made by the Trust in any security or in any manner which shall render it in eligible for exemption under the provisions of the Income Tax Act.

(b). It is specifically stated that the Trust shall not make -any investment or enter into any transactions with the Authority of the Trust or other funds which shall render the trust ineligible for exemption under the provisions of the Income Tax Act or bring it within the mischief of the provisions of Section 13 or other provisions of the Income Tax Act, providing the disallowance of exemption from tax and of the donations received by it.

(c). Any of the clauses in this Trust deed to the extent that it is repugnant to any claim for exemption or concessions for treatment as a public charitable institutions under Trust Law or for purpose of exemption under Income Tax or Direct Tax Laws will be treated as void and modified so as to accord with the requirements of aforesaid Laws.

12. The Trustees shall at all time stand indemnified in respect of any act that they may have been bonafidely done, suffered or committed to be done in respect of matters relating to the Trust.
13. The objects of the Trust shall not be altered except with the previous permission of the Commissioner of Income Tax / Director of exemptions under the income Tax Act. However no alteration, which has the effect of altering the basic character/Objects of the Trust and no Amendment, which may prove to be refuges of section 2(15), 11, 12, 13 and 80G of the Income Tax Act shall be made.
14. The Trust has no immovable property at present.
15. The-income and funds of the Trust will solely be utilized towards the objects and no portion of it will be utilized for payment to the Trustee/ Member/Office Bearers by way of Profit/ divided/interest etc.

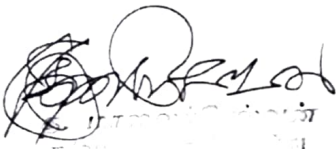

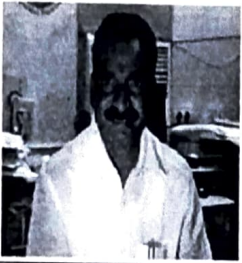
